- 3) providing free or low cost meeting space to five non-profits averaging between 3 and 10 meetings per group each 2-3 hours long

- 5) offering 170 weekday program sessions (238 hours) between Labor Day and Memorial Day
- 6) offering 21 days of science programming (128 hours)

- 8) hosting 5 "Arts in Action" programs featuring local artists and their talents in a hands-on format
